TRANSFER OF REGISTERED KEEPER/OWNER

This form must be completed and signed by the old registered keeper/owner to record the transfer of registered Hackney Stallions, Mares and Geldings. It must then be passed to the new registered keeper/owner who is responsible for sending it, together with the fee, to the Secretary, Haydon Farm Cottages, Sutton Parva, Tytherington, Wiltshire BA12 7AF.

REGULATIONS AS TO THE ISSUE OF CERTIFICATES OF TRANSFER

- (a) Certificates of Transfer are issued to record the transfer of registered Stallions, Mares and Geldings.
- (b) The new registered keeper/owner who shall be deemed to be the person responsible for applying for a Transfer Certificate and pays the fee on each Transfer.
- (c) All registrations of Transfer in respect of which certificates have been issued are inserted in the next Year Book and Stud Book.
- (d) The registered keeper/owner is responsible for ensuring the animal is properly registered.
- (e) The registered keeper/owner is not necessarily the legal owner.

INSTRUCTIONS

Owners and Keepers with primary responsibility must ensure their horses are correctly identified and be able to produce the passport without delay in the event of an inspection. The passport must accompany the horse at all times unless stabled or at pasture, or moved on foot when the passport can be made available within three hours.

On receipt of the Passport please check all details are correct, and sign it on the owner's page. Unauthorised entries anywhere else in the passport will render the Passport invalid.

This document must be returned to the Hackney Horse Society

- if the equine changes ownership (within 30 days)
- if any alterations to markings are required, eg addition of permanent ID marking, update of adult colour (if different to foal colour), transfer to gelding etc
- if extra pages are required for vaccination record etc
- if the document is damaged
- when the equine dies, for cancellation of the document (within 30 days), the passport can then be returned to the owner after cancellation if required
- by the finder, if lost

The Hackney Horse Society must be notified immediately if this document is lost.

Possession of this document does NOT constitute proof of ownership.

No person may hold more than one Horse Passport for any pony at the same time.

The document remains the property of the Hackney Horse Society.

The registered owner is the owner whose name appears in the records of the Hackney Horse Society.

When the equine to which this passport relates is sold, the seller shall give the passport to the buyer and the new owner shall return the Passport to the Hackney Horse Society within 30 days of sale, providing details of the new owner, and accompanied by the completed transfer form and correct fees.

Loss or damage of the document must be notified to the Hackney Horse Society within 30 days of the loss or damage. Damaged documents must be returned to the Hackney Horse Society for replacement. Applications for a duplicate passport should be accompanied by the correct fee.

The Society reserves the right to require any person in possession of a Hackney Horse Society passport to produce it on reasonable demand .

No person may hold more than one Horse Passport for any equine at the same time.

You do not need to sign the Section IX declaration until the animal has been given prohibited medication unless your animal is in Scotland, in which case Section IX must be signed. Defra are suggesting that you think carefully before you voluntarily sign your horse out of the human food chain as a 'not intended' declaration can never be reversed. They make the point about the cost of euthanasia, the fact that current options for euthanasia may not be available in the future and that new owners may wish to have the options open for dealing with the animal at the end of its life. They say that 'leaving the declaration unsigned doesn't mean you have to elect for abattoir euthanasia but you have kept your options open in case circumstances change'.

Non-discrimination between members

In order to comply with zootechnical legislation, the Hackney Horse Society declares that it does not discriminate between members.

The Data Protection Act

Under the terms of the Data Protection Act the Society has a responsibility to inform data subjects (equine owners) about the intention to collect data (which includes personal information relating to an equine owner's name and address) and how that data will be used. Information supplied in connection with your application and other horse passport based information about horse and owner is held in order for the Society to carry out its mandatory requirements as a passport issuing organisation. From time to time the Society is required to make such information available to Defra and recognised enforcement authorities in order that they may carry out their responsibilities regarding the implementation of the horse passport legislation. The information will be uploaded to Central Equine Database (CED) The Society will also publish the data in the Hackney Horse Society Stud book.
